1. Receive an update on the collaboration between Central Health, the City of Austin, Travis County, and Ending Community Homelessness Coalition (ECHO) to identify investments in services for people experiencing homelessness.

They shared that Central Health, ECHO, the City of Austin, and Travis County are committed to a shared vision for seamless physical and mental health care to meet the needs of people experiencing homelessness. Collaborative efforts include identifying previous and planned investments with key initiatives such as:

- expanded ATCEMS services;
- MAP and disability assistance at service sites;
- partnership with PSH HCC; support for Integral Care and the Sobering Center;
- expanding access to primary medical, behavioral health, dental, and specialty care through direct services and contracted investments;
- significant investments to support Bridge Teams, Mobile Teams, and Transitions of Care programs;
- adding respite beds to close gaps between hospitals, skilled nursing facilities, homes, and the streets.

In addition to the above work, Central Health continues to make significant investment in respite care including the addition of respite beds at the former CEC.

2. Receive an update on Central Health facility and service needs identified in the Service Delivery Strategic Plan.
